**TOWN OF DELHI RESOLUTION #11 In the Matter of the Adoption of
Local Law #1 of 2010 Entitled "Dog Licensing Law"**

WHEREAS, in accordance with Article 7 of the New York State Agriculture and Markets Law, the Town of Delhi seeks to adopt a Dog Licensing Law; and

WHEREAS, the proposed Law was presented to the Town Board at least 7 days prior to the Town Board Meeting on November 15, 2010; and

WHEREAS, the Town Board adopted a resolution on Nov. 1 2010 scheduling a public hearing on the proposed Law for November 15, 2010; and

WHEREAS, after being duly published in the Town's official newspapers proving notice to the public, the public hearing on the Proposed Local Law No. 1 was held on November 15, 2010 at the Town Hall, and

WHEREAS, the Town Board reviewed and considered all public comments received on the proposed Law; and

WHEREAS, the proposed Law was on file for inspection at the Town Clerk's office prior to the hearing and during the public hearing process; and

WHEREAS, the Town Board has caused to be prepared a Short Environmental Assessment Form (EAF) pursuant to the mandates of the State Environmental Quality Review Act (ECL Article 8 and 6 NYCRR Part 617) for the proposed Local Law; and

WHEREAS, the Town Board has duly considered the contents of the EAF for the Local Law and completed Parts 2 and 3 thereof; and

WHEREAS, the Town Board has identified the relevant areas of environmental inquiry and taken a hard look at them for the proposed Local Law; and

WHEREAS, the Town Board now determines to issue a negative declaration under SEQRA for the proposed Local Law thereby complying with the mandates of the State Environmental Quality Review Act;

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS BY THE

TOWN BOARD OF DELHI, DELAWARE COUNTY, NEW YORK:

THAT THE Town Board of the Town of Delhi hereby issues a negative declaration pursuant to SEQRA for the Local Law, and further determines that the proposed Local Law entitled "Dog Licensing Law", attached hereto and made a part hereof, is hereby adopted as Town of Delhi Local Law No.1 of the year 2010; and

IT IS FURTHER RESOLVED, that the Town Clerk and the Attorney for the Town are hereby directed to take such actions as are necessary to implement this resolution and effect adoption of the state Local Law.
