H 7 Resolution for Public Hearing on the Adoption of a Local Law For Flood Damage Prevention

WHEREAS, the Town Board of the Town of Delhi, New York (the "Town") deems it advisable to maintain its eligibility to participate in the National Flood Insurance Program ("NFIP");

WHEREAS, new Flood Insurance Study and Flood Insurance Rate Maps establishing 100 year base flood elevations for the Town have been completed by the Federal Emergency Management Agency ("FEMA");

WHEREAS, to maintain eligibility in the NFIP it is necessary for the Town to adopt the new Flood Insurance Study and Flood Insurance Rate Maps into its floodplain management regulations;

WHEREAS, the New York State Department of Environmental Conservation ("NYSDEC") has also instructed the Town Board to update its Flood Plain Local Law to conform to the current rules and regulations required by FEMA; and

WHEREAS, the Town Board deems it advisable to adopt a local law that repeals and supersedes Local law No. 1 of the year 1987 of the Town of Delhi entitled "Flood Damage Prevention Local Law" to adopt the new maps and to incorporate the current FEMA regulations regarding flood plain management.

NOW, THEREFORE, BE IT RESOLVED, that said Town Board shall meet at the Town Hall, 5 Elm Street, Delhi, New York, on <u>Norb</u>, 2012, at <u>7</u> OP.M. to hear all persons interested in the manner of the adoption of the local law, and be it

FURTHER RESOLVED, that the Town Clerk is hereby authorized and directed to publish notice of said hearing in the Walton Reporter and the Delaware County Times, the official newspaper of the town, and to post copies of such notice in the manner provided by law.


